

CHAMBERS, 1307 S. Missouri

When Ruby Chambers moved into her house in 1971, there was one shrub and no grass. It wasn't long befoe she started planting trees, lilacs, althea, honesuckle, crepe mrytle and roses.

Her sister, Sue, lived in Albuquerque, and one of her coworkers sent Ruby three named iris. One of those was William Setchell (which to this day is her favorite). She enters one in the iris show every year.

Sue moved back to Roswell in 1984. One day the sisters were sitting under the tree in the back yard discussing how nice a deck would be. Within two weeks they had a 14x16 deck surrounding the tree.

In 1991, they toured some gardens with ponds. Ruby had her son dig a pond, then she built a waterfall. They decided to build another section of deck to the edge of the pond.

Last summer, another pond was dug and a bridge was added. There are several varieties of fish and water plants in the pond.

The rest of the back yard consists of flower beds with gravel pathways between. The deck is decorated with containers of plants.

A bed of 22 varieties of reblooming iris was added to the front parkway. Many other annuals and perrenials are grown in the gardens as well. There are 425 named varieties of iris.

SMITH, 1407 S. Sunset

Rex and Laverne Smith's property consists of two and a half acres beside the Hondo river channel. It includes a large man-made pond, the original irigation source for acres of orchard, and crops on both sides of the Hondo. The pond and farm were established some 90 years ago by the first engineer on the twin dam project designed to impound and control release of the waters of the Hondo river. The two and a half story brick home north of the Smith's house is the original home on the property. The other homes in the secluded "Del Sumbre Estates" were built in the late 50's - early 60's.

Mature trees, some of the oldest in Roswell, are at one and the same time the outstanding feature of the area and its largest problem...roots. The tree root systems have prompted the Smiths to experiement with a large raised flower garden east of the center of the property. Roses and iris are the primary plants grown here. The new rose garden beside the house is also raised.

The Smiths have lived here for ten years, working to augment the neglected soil and to enhance the quality of landscaping. They have added steps, railroad tie borders on the drive, new brick fencing, compost bins and new planting areas.

The pond is the most unusual feature of the landscaping. It is ringed with iris, water plants, filled with water lillies and populated by bass, catfish, grass carp and lots of frogs and turtles. There are 3 Bald Cypress trees at the S.E. corner.

The iris collection is relatively new. The Smiths collected iris for many years with no concern for the names of the varieties. Only recently have they been concerned with names for their acquisitions.

HARRIS, 1007 Highland Road

Bill and Bettie Harris started gardening in Roswell in 1953. They planted reblooming iris from the very beginning. Today they grow about 80 remontants, carefully selected from the hundreds that are available. There are two display beds of rebloomers in the city garden in the "Y" across from their home. They have taken care of this garden for the city since 1982. The Harris's and this bed have been featured in the NEW MEXICO magazine.

Companion plantings of roses, lilies, dahlias, daylillies, peonies, bulbs and annuals compliment the iris.

Outstanding reblooming performers are: Beleek Pastel, Black Magic, Blessed Again, Coral Chalice, Dorcas Lives Again, Earl of Essex, Fall Primrose, Feedback, Garden Grace, Harvest of Memories, High Ho Silver, I Do, Orchid Cloud, Perfume Counter, Pinkness and Queen Dorothy.

Several iris plantings are located at their residence as well. East of the house is a planting of 29 Spurias as well as some remontant iris.

The back yard has 27 Louisiana, 12 Siberian, a bed of MTB's and remontants as well as many other kinds of flowering plants.

The Harris's enjoy showing the gardens to interested visitors. So do drop by when you are in the area.

JOBE', 3109 Diamond A Drive

Wayne and Leslie's gardens have been planted four years come November. This garden shows what can be done in a short time.

The one acre plot is mostly flower beds and pond, no lawn. There were established trees such as Pecan, Scarlet Oak, Pinon Pines and fruit already there. Black plastic covered with wood chips covered most of the yard. A few of the flower beds were there also, although there were no desirable plants in most of them. The fact that there was no bermuda grass sold them on the yard!

The first task at hand was to plant the "garden" they trucked from Houston (in an old mail truck 24 ft. long, 8 ft. wide and 8 ft. high. Stacked to the top, with a portable pond included).

The van lines also brought some of their plants including the 100 iris. The "portable pond" kept their waterlillies and fish (that survived the

trip) until the following summer, when their two ponds, stream and bridge were finished. Then it was dismantled and is now 3 raised iris beds. Over 800 varieties of named iris are grown in their gardens. The iris date back to the 1700's (Florentina) to many 94's and even one '95. These include Louisiana, Spuria, Siberian, Japanese and Species. 160 rebloomers are also included.

The guest beds include iris from Roger Nelson, Jim Ennenga, Dave Niswonger, Tim Stanek and Hooker Nichols.

Many other companion plants are grown also. Roses, peonies, lilies, annuals, perrenials, native plants and even tropicals such as ginger, orchids, ferns, azaleas, to name a few.

There are benches, chairs and an arbor where you can sit and gaze out over the pond and gardens. Visitors are always welcome!

The minutes from the 1993 AIS Convention business meeting were read and approved with one correction being noted: Bob Steel was also a past RVP.

The Treasurer Report was read by Floyd Stopani, Treasurer. Mr. Stopani reported that RVP funds were given by the New Mexico Iris Society (\$25), Pecos Valley Iris Society (\$100), Roswell Iris Society (\$100), and the Albuquerque Aril Society (\$150). The treasury report was accepted (see Enclosure 1).

A motion was made by Karen Bergamo that \$25 be given to a library fund in memorial of Elaine Coursey. The motion was seconded by Barbara Figgy, a vote was taken, and the motion passed (see Enclosure 2).

Karen Bergamo made an additional motion that \$25 be given to the AIS in memorial of Kay Nelson Keppel. The motion was seconded by Barbara Figgs, a vote was taken, and the motion passed (see Enclosure 3).

Letha Dent made a motion that \$25 be given to the AIS in memorial of Beth and Les Kilgore. The motion was seconded by Suzanne Swizer, a vote was taken, and the motion passed (see Enclosure 4).

Youth Chairman Karen Bergamo reported that Isaiah Price from Albuquerque, NM, received the 1994 Top Youth Member award in Region 23. She stated that all Region 23 members need to encourage youth activities, and expressed the need for newsletter input and bulletin articles pertaining to any youth iris activities.

Judge Chairman Barbara Figgs reported that Rita and Scott Jordan were apprentice judges and Wayne Jobe was a student judge.

Newsletter Editor Doug Goodnight asked for cooperation from AIS Region 23 membership in providing input for the AIS Region 23 spring and fall newsletters. Please mail your inputs to Doug Goodnight, 1005 Gamblin Lane, Hobbs, New Mexico, 88240.

RVP Maxine Perkins reported that Leslie Jobe had accepted the position of Membership Chairman for Region 23, which has 223 members.

National Membership Chairman Marilyn Harlowe requested to speak to the AIS membership regarding expiration dates of the National memberships. She stated that there were two expiration dates: June and December. Anyone joining October 1 would not begin membership until January 1; anyone joining April 1 would not begin membership until July 1. She also reported that there was a great deal of one-year membership losses and asked everyone to commit to a three-year membership if possible.



Old Business:

The RVP Fund Committee (Doug Goodnight, Bill Huey, and Suzanne Swizer) appointed by RVP Maxine Perkins at the 1993 Region 23 meeting reported their research of the RVP/Convention Funds and recommended the following motion:

"The Regional Vice President shall be entitled to reimbursement in the amount of \$500 for each of the annual fall and spring American Iris Society meetings to cover registration, travel, and subsistence expenses. To implement the reimbursement of these expenses, the Regional Vice President shall submit to the Regional Treasurer receipts for registration, travel, and subsistence up to \$500 (maximum) for each meeting if funding is available."

The motion was seconded by Bill Brown. For the duration of the discussion, the gavel was passed by RVP Maxine Perkins to assistant RVP Karen Bergamo. The amendment passed (Enclosure 4).

A motion was made by Pete McGrath to change Policy No. 1 to read as follows: 50 percent of regional convention funds shall be directed to the host group and 50 percent to the region. The regional meeting fund will be earmarked with a cap of \$1000 so the region can bear the burden of all losses. All additional profits coming to the region shall be reverted to the RVP operating fund. The motion was seconded by Susan Swizer and the motion was passed (see Enclosure 5).

The meeting was adjourned at 12:30 p.m. on September 17, 1994.

Ballots for the Favorite Guest Irises were returned by 658 visitors to the 1994 Portland area convention. Over 9600 votes were tallied for a large number of varieties.

REGION 23 - AMERICAN IRIS SOCIETY BY-LAWS

ARTICLE I. NAME

The Name of this organization shall be Region 23 of the American Iris Society.

ARTICLE II. OBJECT

The object of Region 23 - AIS shall be:

(a) To assist its members in study and in efforts to advance the culture and improvement of irises.

(b) To coordinate regional iris activities and expedite the policies of the American Iris Society.

ARTICLE III. MEMBERSHIP

All AIS members residing within the boundaries of New Mexico shall automatically be members of Region 23 - AIS.

ARTICLE IV. DUES

There shall be no dues assessments.

ARTICLE V. OFFICERS

The officers shall be Regional Vice President, Assistant Regional Vice President, Treasurer, and Secretary.

ARTICLE VI. DUTIES OF OFFICERS

Duties of the Regional Vice President shall
be:

- (a) To interpret the policies and rules of the American Iris Society to the membership.
- (b) To appoint the Chairman of the Judges Training and Membership Committees and other Chairmen as necessary.
- (c) To serve as ex-officio member of all committees except the nominating committee.
- (d) To preside at all called meeting of the Region.



Duties of the Assistant Regional Vice President shall be:

- (a) In the absence of or due to the inability of the RVP, the Assistant RVP shall assume the duties and exercise the power of the RVP.
- (b) Should a vacancy occur, the Assistant RVP shall assume the office of RVP for the unexpired term.

(c) Approval of this appointment will be confirmed by th AIS Board of Directors.

Duties of the Treasurer shall be:

- (a) To serve as custodian of all funds of the Region.
- (b) To disperse Regional funds as authorized by the RVP.

Duties of the Secretary shall be:

- (a) To record the minutes of all regional meetings.
- (b) To receive and transmit any regional items of business as required by these By-Laws or as directed by the RVP.

ARTICLE VII. NOMINATING COMMITTEE

- (a) The Nominating Committee shall consist of five regional members each having at least five years of continuous AIS membership.
- (b) Duly affiliated societies shall send names of candidates (who have consented to serve if elected) to the RVP by Feb. 1 of the election year. Each affiliate society may name one candidate. Names of these candidates shall be published no later than March 15 in the Spring Newsletter, along with a ballot.

(c) Ballots must be returned to the RVP prior to April 5.

- (d) The five candidates who receive the greatest number of votes will serve as the Nominating Committee, and the individual receiving the greatest number of votes will act as Chairman.
- (e) If five candidates are not timely submitted by the affiliate societies, the RVP shall name sufficient candidates to fill the committee, and all nominees shall be

considered elected without balloting. The RVP shall designate the Chairman. The RVP shall make an effort to fill any such vacancies with candidates from Affiliates not already represented.

(f) The Nominating Committee shall serve for

three years.

(g) The Nominating Committee shall present a slate of officers to the RVP by June 1 of the election year.

ARTICLE VIII. ELECTION OF OFFICERS

(a) The RVP shall present the proposed slate of officers to the membership by June 15.

- (b) Additional nominations may be made by petition of the general membership. Each petition shall be signed by the nominees and endorsed by at least 5% of the regional membership as determined by the latest AIS computer printout. Any such petition shall be returned to the RVP prior to July 5.
- (c) If no nomination petitions are received by the above date, the slate of officers as presented by the Nominating Committee shall be deemed elected without necessity of a vote.
- (d) Should a nomination petition be timely received per paragraph (b) above, the RVP shall mail a ballot listing all nominees to the membership prior to July 20.

(e) Election shall be by secret written ballot, and a plurality of votes cast shall be necessary to elect. Verbal voting will not be considered.

(f) Single ballots shall be provided for all members in good standing as reflected by the latest AIS computer printout. Affiliate societies shall not receive ballots.

(g) Ballots shall be returned to the Chairman of the Nominating Committee for tally prior to Aug. 15. Envelopes shall be retained to determine timeliness of ballots. Ballots not postmarked prior to the deadline shall not be counted. Ballots which have been altered in any manner shall not be counted.

(h) Counting and tally of votes shall be done by the Chairman of the Nominating Committee together with two other Region 23 members not on the committee, as approved by the RVP.

(i) Ballot envelopes shall not be opened until counting and tally is commenced

per paragraph (h).

(j) Vote tally along with ballots and envelopes shall be turned over to the RVP immediately upon completion of tally, who shall retain same for 30 days after the next regional meeting, at which time they shall be destroyed if no contest exists.

ARTICLE IX. VACANCIES

- (a) In event of vacancy in the offices of Assistant RVP, Secretary, or Treasurer, the regional Nominating Committee shall make nominations for replacement, which shall be published in the next newsletter or in a special ballot for membership vote.
- (b) In event of a vacancy on the Nominating Committee, the position will be filled by RVP appointment.

ARTICLE X. RULES AND POLICIES

- (a) A statement of Rules and Policies shall be made and attached to these By-Laws.
- (b) Rules and Policies are subject to implementation, revising, or rescinding by a majority vote at any Regional Meeting.
- (c) Such Rules and Policies shall not be in conflict with existing By-Laws.

ARTICLE XI. CONFLICTS

These By-Laws or any amendments thereto shall not be in conflict with rules and policies of the American Iris Society.

ARTICLE XII. AMENDMENTS

(a) Amendments to these By-Laws may be proposed at any Regional Meeting by any member of Region 23, and with the consent of the majority of members present, shall be presented to the membership with a written ballot in



the following Spring Newsletter.

(b) Ballots shall be returned to the RVP within 60 days, and after tally, the Amendment(s) will be considered adopted if a plurality of the votes cast so indicate. The RVP shall retain such ballots as outlined in Article VIII, para. (j).

ARTICLE XIII. PARLIAMENTARY AUTHORITY

"Robert's Rules of Order Revised", latest
edition, shall be the parliamentary authority
for procedures not covered by these By-Laws.

REGION 23 RULES AND POLICIES

1. REGIONAL MEETING:

50 percent of regional convention funds shall be directed to the host group and 50 percent to the region. The regional meeting fund will be earmarked with a cap of \$1000 so the region can bear the burden of all losses. All additional profits coming to the region shall be reverted to the RVP operating fund.

2. REGIONAL VICE PRESIDENT:

The Regional Vice President shall be entitled to reimbursement in the amount of \$500 for each of the annual fall and spring American Iris Society meetings to cover registration, travel and subsistence expenses. To implement the reimbursement of these expenses, the Regional Vice President shall submit to the Regional Treasurer receipts for registration, travel and subsistence up to \$500 (maximum) for each meeting if funding is available.
